From AIAM President-Elect **2001, An Architectural Odyssey**

Thanks to you, 2001 was a great year for AIA Michigan! If you attended one or more of our events during the year you had the opportunity to meet new clients or connect with existing ones, to obtain quality continuing education credits, to explore some outstanding architecture and to renew fellowship with other architects and allied professionals.

In January, many of you participated in the annual Leadership Retreat in Traverse City led by President Andy Vazzano. It featured the first Issues Forum designed to promote chapter leadership on issues of importance to all architects in Michigan. A lively discussion led to interesting and provocative action plans.

In February, the Design and Construction Expo at the Silverdome connected all members of the design and construction team. The Grassroots event in Washington, DC gave chapter leadership a further opportunity to shape the national AIA agenda, and also to influence and educate our elected leaders in Congress as to the substance of that agenda.

In March, AIA Michigan members participated in the Health Facilities Conference at Shanty Creek sponsored by the Michigan Architectural Foundation. This engaging event has become a model for such client/architect events nationwide.

April brought the inaugural meeting of the Technology in the Workplace conference in Mt. Pleasant. Conceived and organized by President Vazzano, the event showcased presenters who informed and challenged those present to move out of the box and into a more creative thought process. The 2002 event promises even better opportunities for attendees.

In May, we visited the state capital in Lansing and articulated our legislative issues to our legislators. The Howling was a success and saw members from all corners of the state becoming lobbyists for a day. From there, many of you went on to Denver for the AIA National Convention and enjoyed excellent seminars, presentations, and the best trade show anywhere. Also, in May the AIA Michigan Honor Awards program was held at Cranbrook. One of the biggest turnouts in recent memory filled the auditorium to honor new fellows, a new Gold Medalist, some really nice projects, and other recognitions. It was a great event at a great location. If you didn't make it in 2001, try to attend in 2002!

In June, the ExCom kept busy working on partnering with allied professionals and meeting with past presidents of AIA Michigan in Kalamazoo. But in July everyone took a break and rested from all the AIA activity.

August found many of you on Mackinac Island enjoying the Mid-Summer Conference at the Grand Hotel. Our annual meeting and Board meetings were joined by incoming AIA President Gordon Chong who informed us of his vision and action plan for 2002. All of you congratulated Gene Hopkins, FAIA of the Huron Valley Chapter on being elected as a vice president of AIA!

September brought us together at

Camp Hayo Went Ha for a weekend of design dialogue and fellowship on the shores of Torch Lake. Those in attendance enjoyed intriguing projects designed by AIA Michigan members from every corner of the state. There was also much reflection on the tragic events that had transpired just four days earlier. Architects discussed the impact on America and on architecture. It was good to be among friends and colleagues.

In October, leaders from the seven largest state components of AIA (CA, NY, FL, PA, IL, TX and MI) met in Detroit for an in-depth discussion of issues and agendas for AIA National as well as the large state components. A tour of Cranbrook and dinner there helped to create a working bond between all of the state leaders who attended. Also in October, the annual Education Facilities Conference sponsored by the Michigan Architectural Foundation convened in Grand Rapids. Architects and educators from all over the state were treated to a first-class program of presenters on school design.

November brings the annual ExCom Retreat during which budget, schedule and agenda for the upcoming year are prepared for AIA Michigan Board approval.

Michigan Rehabilitation Code Rules Examined

The Bureau of Construction Codes is in the process of developing a referenced standard for the rehabilitation of existing buildings. This proposed standard will be referenced within the Michigan Building Code for use as an alternative to the current code provisions for the repair, alteration of, addition to, or change of occupancy to existing buildings.

A public hearing will be scheduled for later this year. However, the Bureau has developed a matrix detailing all information relative to the proposed code changes. AIA members are invited to review the matrix and submit written comments.

The matrix may be accessed on the Bureau's Web site at www.cis.state.mi.us/bcc/rules.htm. Or request a copy by mail to Bureau of Construction Codes, Administration, PO Box 30254, Lansing, MI 48909.

Written comments should be submitted by November 30 and forwarded to Beth Aben at the address above.

Obituaries

We sincerely regret the loss of our fellow members and extend deepest sympathies to their families and friends. The following members have passed away since we last printed obituaries in February, 2001.

JAMES R. LIVINGSTON, AIA

Jim Livingston of Royal Oak passed away on June 4, 2001. He served on the board of Smith Hinchman and Grylls until his retirement in 1986. A UofM graduate, Mr. Livingston was in charge of research and scientific laboratories designed by SHG. He was an active member of AIAM, including serving on the annual convention committee. He was also a member of the National Association of Housing Redevelopment Officials and he served as vice president of the Detroit World's Fair Inc.

THOMAS J. SEDGEWICK, FAIA

Clio architect Tom Sedgewick passed away on September 23, 2001. He was a graduate of the University of Detroit, a U.S. Army veteran of the Korean War, and owned and operated Water Street Design for more than 40 years. A Fellow of the AIA, Tom was a recipient of the AIAM Gold Award. He served on the Michigan Architectural Accrediting Board and the National Architectural Accrediting Board. He was also elected president of the National Council of Architectural Registration Boards. Tom also served on many civic boards and in his church, where he served as lector, as a member of the Administration Committee and lay missionary to Ghana, West Africa. A. CALVIN SMITH, AIA

Well-known Saginaw architect Cal Smith died on June 20, 2001. He was 68. His architectural firm, Smith Associates Inc., merged with RC Engineering & Environmental Inc. in 1995 to become RC Associates Inc. A Detroit native, Mr. Smith graduated from U of M. He was a Navy pilot, and also served with the Saginaw County Sheriff's Auxiliary.

BERNARD J. WALESKY, PROF. AFFILIATE

Bernard Walesky, of Hawthorne, Calif., passed away on February 21, 2001, at the age of 87. Mr. Walesky was a construction builder with Wright & Walesky during the 1950s. Before retirement, he was associated with the firm of Walter J. Rozycki, Architect as administration and job captain. He was a professional affiliate member of AIA Detroit.
